Mr. Dilbert,

What is needed from the Port Authority is to have the following:

When the Allure of the Seas is in port:

- A) Three guaranteed tender spots by the Royal Watler port.
- B) The Premier Anchor Position closest to the Royal Watler Port.

Port Management:

- C) To be the over arching coordinators for the placement of the Security Modular Housing and to work closely with the Flowers Group and Massive with the traffic flows and security requirements.
- Reminder: The land adjacent to the Port closest to Jacques Scotts has been approved by Dart for our use for these purposes.

Other MOT:

1) Waiving of Passenger Tax.

Mr. Dilbert I think the passenger fees are mandated by law but I am not sure which law it is incorporated within. Perhaps Mr Hurlston, Clemens or Joey would know because that would determine whether the Port Authority has the authority to waive or if it is a cabinet decision. (As the per passenger fee seems to be a break between the port, general government and an environmental fee it may be a mix of both.) *Joey Woods seems to be very knowledgeable in regards to this tax.

Note: As of Dec 26 2011 the per passenger tax/fee was \$243,166.86 USD (\$204,260.16 CI). (When I get to my computer later tonight I will be able to indicate how many passengers this represents)

- 2) Mr. Dilbert to answer your other question, RCCL has not frozen the fees as they pass our head tax onto the customer who purchases the package with the Cayman Islands as a destination on the itinerary. As the days pass, the more persons that purchase without the Cayman Islands on the itinerary will not pay the tax and will be included in the number to be waived moving forward.
- 3) RCCL needed a letter to indicate the progress we had made on the items mentioned above, however if we get these items approved then the letter would indicate the following components: A) Approved premier anchoring spot B) Approved 3 guaranteed tender positions C) The fact that the CI Gov will provide the modular housing as outlined D) the fact that the CI Gov will provide the security machines and the human resources as outlined E) the CI Gov will waive the per passenger head tax up to the point when the CI is officially on the itinerary and able to be sold to customers.

I hope the above helps.

Mr. Dilbert,

Mike Ronan from RCCL recently contacted me outlining that he needs to understand "officially" where we are with regard to the list of items discussed and which are resolved and those still pending including likelihood of approval. He is asking for an official letter from the Ministry to RCCL with the gov't position so he can put together with their internal review comments and go to their Senior Management for a decision asap.

As a reminder the items that were requested were as follows:

- 1) Seven Tenders with a 300 passenger capacity.
 - a. It is our understanding that RCCL has worked directly with the on island tender company and has confirmed this requirement can be met.
- 2) Three guaranteed tender spots.
 - a. Port confirmed this previously but we need to double check to ensure this is still the case.
- 3) Shoreside Security Building:
 - a. We have worked and received estimated costing for the physical modular building, the security equipment and the human resources and the Premier through the Ministry believes that the additional funding required will be approved by Cabinet. (Not sure if you have the estimated timing that could be included.)
 - b. We have overarching agreement that the adjacent property next to the Port will be made available for the location of the security building.
- 4) Modifications to the landing to allow for two-level loading:

- a. RCCL had discussions with the tender company and understands that due to the vertical positions of the disembarkation points on the tenders that two level loading will not be possible however this does not pose an issue to this opportunity.
- 5) Premier Anchor Position:
 - a. This was agreed by the Port previously but we need confirmation that this is still the case.
- 6) Shoreside Security Personnel:
 - a. This was dealt with in point 3.
- 7) Waiving of Passenger Tax.
 - a. Those persons who have booked prior to the Cayman Islands being sold as part of the itinerary would not have paid the tax and RCCL can't charge them after the fact.
 - b. The Premier through the Ministry is confident that the per passenger fee for those passengers who have booked prior to the CI being on the itinerary will be waived through Cabinet. (Not sure if you have an idea of timing on this item?)

Other:

1) An additional item that RCCL wanted was 50% reduction in tender fees. We are currently working on this issue with the tender company as the government is not in a position to pay for this as an incentive as the operation is privately owned and operated and the government will have to make a significant investment for the security requirements etc.
